MISTRIAL

Comes now, a Judgment and Order from **The Human Rights Tribunal International**,

WHEREAS, Claimant has brought forth testimony validating by affidavit gross negligence of human rights and other serious criminal crimes this Tribunal must declare a Mistrial due to several issues present in deriving a true case matter. Reasons for mistrial as follows:

1. Claimant's social, political and national status has changed drastically from the onset of the evidence to the point that this matter cannot be properly adjudged from the old person to the new person.
2. Secretary of State for the United States was not properly served process in evidence package due to incorrect email addressing.
3. Evidence declaring that only 3 of the 13 Respondents were served process.
4. Actions of Claimant in 2016 were self-injurious to the old person of the Claimant.
5. Prosecutor's verbal remarks from recording minutes 13:07:53 ring clearly and the loudest to be observed by all men.

7. Notice, by Claimant, of political, social and union status have not been properly revealed to Respondents appearing anywhere in this evidence offered.
8. Claimant did not notify previous courts, personnel, law enforcement officers and other agents of the State of Florida in regard to his new status as is proper to give notification in the pursuit of his new nationality, political status and social compact. Therefore the items mentioned by Claimant are unfounded with the entire of list of (13) Respondents toward his claim and the timeline of events offered in evidence.

Claimant is free to seek his own counsel to move forward as he is so inclined. This Tribunal bears no prejudice toward Claimant nor Respondents. Frame and information have been critically weighed in this matter and shall not be considered further in their current capacity nor offering.
