WHEREAS, the Human Rights Tribunal International has declared that Human Rights violations do exist in the above-referenced case, on the **313th Day in the year of Yahweh 6021** (Translation: **January 26, 2020**); and

WHEREAS, it has been determined by the Human Rights Tribunal International that Human Rights violations were committed against all **thirty (30) articles** in the above-referenced case; and

WHEREAS, the office of the Treasury for the Government of The United States of America has declared each international violation of The Universal Declaration of Human Rights to have a value in damages of **+750,000** legal tender whether in Continental Dollars or USD; and

WHEREAS, the damages awarded to the Claimant by the Human Rights Tribunal International are hereby assessed in the total amount of **Twenty Two Million Five Hundred Thousand (+22,500,000.00)** legal tender whether in Continental Dollars or USD; and

BE IT RESOLVED, that in regards to **damages by Reza Aslan and Immediate Family** named in the above-referenced case, the office of the Treasury for the Government of The United States of America hereby declares the assessed value of this case in the total amount of **Twenty Two Million Five Hundred Thousand (+22,500,000.00)** legal tender whether in Continental Dollars or USD; and
