**RELIEF SOUGHT**

**Comes now the Government of The United States of America by and through the American National Union Legal Department and ANU liaison moves this court, pursuant to Law of Nations, and the Universal Declaration of Human Rights for The United States of America to direct the Human Rights Tribunal to file a bill of particulars in the subject case on the grounds that it is necessary for the legal liaison to explain the charges against Respondents so that there is a due process of order for all.**

**BURDEN OF PROOF /BURDEN OF REBUTTAL**

## FACTS

RESPONDENT JOSEPH ALCOFF, and any of his alias are here by charged with attempted murder due to the fact that he desires the violent overthrow of a government. In committing such an act, he would entertain the thought of killing a person.

Violation by way of Alcott – Antifa leader uses aliases to spread radical and often violent rhetoric while concealing his actual identity. Smash Racism DC organizer Jose Martin, also known as “Chepe,” is a radical communist and Antifa leader operating in the U.S. He advocates for the violent overthrow of the government and for the murder of the rich and claims to have international involvement in left-wing movements.
