

Affidavit of Facts



Comes now, Samuel German Valencia, (hereinafter "Affiant") being competent to testify and being over the age of 21 years, after first being duly sworn according to law to tell the truth to the facts related herein states that Affiant has firsthand knowledge of the facts stated herein and believes these facts to be true to the best of Affiants knowledge and belief.

The affiant claims that the following facts will prove beyond a shadow of a doubt that the affiant has experienced human rights violations from the perpetrators listed herein. Further, the affiant claims that the perpetrators listed herein have knowingly, willfully and intentionally committed acts of Human Rights Violations against the Universal Declaration of Human Rights in the name of the U.S. and under the protection of the U.S., and

Affiant states sequence of events from beginning to show a pattern:

On or about 1999 Affiant pays Federal Estate Tax to IRS Regional Office in Phoenix, AZ. and Arizona State Estate Tax to Arizona Tax Revenue Department. Upon completion of Estate Tax audits, Affiant receives refund; Affiant deposits refund; Affiant receives notice from Estate Tax attorney that the IRS has re-audited the returns and demands an additional 1.3 million USD, Estate Tax on deceased father's estate. Affiant requests to meet IRS Regional Director with Affiant's Estate Tax Attorney; Affiant is excluded from the

meeting; Affiant is labeled as "Tax Protester" for requesting a meeting with the IRS.

On or about the year 2000, Affiant purchases ranch property and relocates to Whitefish, Montana, and

Days after relocating to Whitefish, Montana, Affiant is confronted by head of Montana Militia and asked what Affiant's intentions are, that is, if Affiant is just "passing through" or intends to stay in Montana permanently. Affiant responds Affiant is there to stay however under no circumstances Affiant is interested in any involvement with the Militia. Several weeks thereafter Affiant learns from a fellow parishioner that Affiant's name is on the local police force bulletin board "Watch List" as a "Tax Protester", "New York Mafia" and "Sovereign Citizen". Affiant does not know any Tax Protestors, Sovereign Citizens nor anyone in the New York Mafia, and

Affiant builds homes on ranch property known as 803 and 805 North Valley Drive, Whitefish, Montana, 59937, which are occupied by Affiant's ex-wife's twin brother, Kevin Patrick Melvin and ex-wife's oldest brother William (Bill) Warren Melvin and his wife Gail Jarvis Melvin, and

Late 2003 Kevin Patrick Melvin dies of a heart attack leaving the home at 803 empty and unattended. Around the year 2004, Affiant and Mary Anne Melvin meet Rob Blair and Rob's wife, Suzanne. Affiant, again at the urging of Affiant's ex-wife Mary Anne Melvin, gave Rob and Suzanne permission to peacefully reside at 803 North Valley Drive, while they search for a permanent home, and

On or about 2005 Affiant is pulled over by a Whitefish Police patrol car waiting at the main intersection several blocks from the ranch while driving Viper "White Mamba" for allegedly touching center line. Officer calls in to Duty Officer Bridger Kelch, who orders Officer Ricci Belgarde-Lamb to arrest Affiant for being a "Sovereign Citizen Domestic Terrorist". Keep in mind that before the events of September 11th, 2001, affiant was listed as a "Sovereign Citizen", after September 11th, 2001, the affiant is now a "Sovereign Citizen Domestic Terrorist" and a danger to society, affiant had no connections to any events to September 11th, 2001, and

Affiant is hand-cuffed and kidnapped; Affiant refuses to be Booked under the "Domestic Terrorist" Profile; Affiant is incarcerated in a windowless cell and subjected to torture; lights are turned off during day; turned on at night; food and water are offered and taken away; plumbing is shut off; Affiant sleeps and urinates on floor. Days later acting City Judge Thomas T. Tornow comes down to the basement cell which prompts one of the officers to ask Affiant "Who the hell are you? A judge never comes down to talk to a prisoner." Judge Tornow threatens Affiant that Affiant will be left to rot while Judge Tornow goes away for a three week vacation to Canada. The Judge orders a psychiatric evaluation. Affiant believes Affiant can not get remedy while kidnapped and accepts Judge Tornow's offer to leave Registration and Tags of Viper in return for release, and

Affiant is forced to be booked under the Sovereign Citizen Domestic Terrorist profile after torture sessions became too much to take for a 63 year old man, and

Municipal Judge Bradley F. Johnson demands Affiant obtain a Driver License, issues a Warrant until Affiant complies, and

On or about 2006, Affiant visits the Department of Justice (hereinafter, "DOJ") Reference Law Library. When departing Helena, Montana, Affiant is victim of attempted murder and kidnapping again. A DOJ Agent Johnson alleges that Affiant's face was recognized by a newly installed facial recognition computer camera at the DOJ Public Library for having an outstanding warrant. Affiant is pulled from the passenger side of car, thrown to the ground and warned that if Affiant makes any suspicious moves Affiant will be shot by nearby Swat snipers; Affiant is ordered to place hands behind his back; handcuffed and placed in a Lewis and Clark County Sheriff Department holding cell in Montana. The Duty Desk Sergeant comments in his twenty years he has never seen so much fuss over an old traffic violation, and

Affiant is forced to bail out and hire attorney to appear in the Helena court regarding old warrant dealing with the City of Whitefish arrest the previous year, and

Affiant and Mary Anne Melvin publish a Legal Notice of Fictitious Marriage in the Kalispell Daily Interlake newspaper January 6, February 2, and February 9, 2007 with corresponding Affidavit of Publication. Several friends and neighbors read and are aware of the published legal notice

and question Mary Anne Melvin if a divorce is pending. Days later Mary Anne Melvin leaves Affiant and moves out, and

On or about 2007 to 2009 – Affiant is tired of the Domestic Terrorist profile and seeks remedy internationally in the form of the right of self determination. Affiant claims the original metes and bounds of The United States of America for the purpose of claiming a Nationality in another jurisdiction away from the U.S. in hopes being able to live in peace. Further, by claiming the original metes and bounds of the original country, maybe that will convince the powers that be in the U.S. that affiant is not a domestic terrorist nor an enemy of the country because apparently a Captain in the Military that served a tour in Vietnam qualifies as a Domestic Terrorist in the U.S. affiant believes, and

Affiant believes that it is around this time that Mary Anne Melvin; Robert (Rob) Blair Young, his wife, Suzanne Young - at 803 North Valley Drive, Whitefish, Montana 59937; Mary Anne Melvin's oldest brother, William (Bill) Warren Melvin, his wife, Gail Jarvis Melvin-at 805 North Valley Drive, Whitefish, Montana 59937 and Floyd T. Huntington, Notary Public for the State of Montana, Mailing Address: 432 East Idaho Street - #238, Kalispell, Montana 59901 begin to conspire against the affiant with the Missoula County, Missoula, Montana; the Lewis and Clark County Helena, Montana; the Flathead County, (Kalispell and Whitefish) and all agents and individuals involved in the previous stated human rights violations in events previously subscribed, and

On April 10, 2010 Affiant is victim of second act of aggression, attempted murder and kidnapping. Agents of the

Missoula and Kalispell IRS office, Flathead County Sheriff Department, ATF Swat Teams, ATF Bomb Squad, Kalispell and Whitefish Police Departments together with Agents from Valley Bank of Kalispell raid and swarm the ranch main house known as 669 North Valley Drive, Whitefish, Montana 59937 where Affiant is living, and

It is Affiant's belief that the raid was executed by false statements made against the affiant by Mary Anne Melvin. There was a concealed safe room in the house of which Mary Ann Melvin is the only one who had knowledge of the safe room. Windows and doors are broken, safe room is broken into. Locks are changed by Valley Bank officers, a home alarm is installed by Grizzly, and security guards are posted at entrance to driveway. Mary Anne Melvin removes contents of choice from the home. Viper collector cars are stolen. Friends of Affiant hear of raid announced on local radio newscast known as "Police Blotter" and inform Affiant that his life is in danger and to not return home. It is Affiant's belief that agents are seeking to confiscate original documents claiming the original metes and bounds of The United States of America and other documents needed by the U.S. to monetize and plunder on behalf of its creditors, and

On July 26th, 2010, #201000016897 Mary Anne Melvin files a Quit Claim Deed to the property known as 803 and 805 North Valley Drive, Whitefish, Montana 59937 to Mary Anne Melvin, and

Sometime in 2010, Affiant's ex-wife, Mary Anne Melvin, begins divorce action against Affiant, retaining a law firm

miles away from Whitefish where Affiant's ex-wife Mary Anne Melvin resides. Affiant is never served until last moment of Decree of Dissolution after being homeless, on the road running for affiants life for two years, and an incident occurred while in Castle Rock Colorado stated in this affidavit to show a pattern of abuse, and

Affiant is pulled over by Castle Rock Sheriff Deputy Cook for allegedly having a dirty and unreadable rear plate; car is impounded; Affiant is kidnapped and arrested for not producing a valid driver's license. Affiant's remaining cash is confiscated; Department issues a prepaid debit card which is not accepted at any nearby hotels. Affiant is released at 1AM; is forced to spend the winter night huddled in a fir tree at a park, and

Prior to March 2011, Affiant makes an unexpected visit to Mary Anne Melvin's attorneys, Molly K. Howard and Amanda Adams at their law firm in Missoula. The topic of discussion is if Affiant agrees to set aside a college fund for Affiant's son, Michael, which Affiant agrees and accepts. At the conclusion of the meeting Molly K. Howard makes the comment. Quote: "Gee, you are not at all dangerous as we had been told. It was nice meeting you." End quote.

On March 29, 2011, in case number DR-10-587B, District Court of Flathead County, MT enters a final Decree of Dissolution of Marriage, wherein the Court orders that Property known as 803 and 805 North Valley Drive be received and owned by Affiant, keep in mind that the affiant is not arrested for domestic terrorism at this time in the same town 2 years later, and the affiant is driving around

the same town without a driver's license for almost a year and was not bothered, and

October 25, 2011, in case number DV-11-778A, District Court in Flathead County, MT orders that Affiant is entitled to the quiet and peaceful possession of the property known as 803 and 805 North Valley Drive, Whitefish, MT 59937, FREE OF ANY AND ALL CLAIMS, LIENS AND ENCUMBRANCES, and

On 11/30/2011 and 3/30/2012 in an attempt to steal the property known as 803 and 805 North Valley Drive, Mary Anne Melvin, under the protection of the IRS a U.S. agency, issues checks paying the taxes through Gail Jarvis Melvin, the spouse of William (Bill) Warren Melvin, Mary Anne Melvin's oldest brother. Months later, Tax Certificate #201200017626 paid by Mary Anne Melvin is issued to Gail Jarvis Melvin by Flathead County Treasurer. March, 2012, Affiant quitclaims property known as 803 and 805 North Valley Drive, Whitefish, Montana 59937 to Paladin International, LLC in an attempt to protect the property from the aforementioned parties. Further keep in mind that William Melvin and Rob Blair are well known in the same area for speaking out against the IRS and the powers that be in the U.S. with all threats of violence against the U.S. and they are supported by the IRS and the U.S. in their theft and violence, and

On March 26, 2012, Attorney Tim Baldwin begins eviction action against Robert (Rob) Blair Young, Suzanne (Susanne) Young, William (Bill) Warren Melvin and Gail M. Melvin. From April, 2012 to November 1, 2012 Tim Baldwin,

Process Servers and Sheriff's Department are unable to serve Notice and Court papers. Access to the property, a county road is blocked and gated. Servers are run off by the Rob Blair brandishing weapons. The Sheriff's Department refuses to enter forcibly because it is too dangerous for their deputies and they said they could not handle the threat against them. Further, the Sheriff was too scared to deal with the issue, and

On July 2, 2012, Quitclaim Deed to Paladin International LLC as amended is approved and recorded; Flathead County Recorder #0976723, and

During this same period or shortly thereafter, an IRS agent visits Tim Baldwin (name unknown, emails to prove validity) at his office and threatens Tim Baldwin enough to request removal from the Paladin International, LLC litigation, and

On December 16, 2013 Executor Letter transfers ownership of Paladin International, LLC, to Swift form Systems, Inc. for the consideration of obtaining a retainer fee for International Attorney's, and

On February 14, 2014, GRANT DEED #201400003243 Document Recorded on 2/21/2014 at 2:02:00 PM; Grantors: PALADIN INTERNATIONAL; Grantees: SWIFFFORM SYSTEMS, and

May 19, 2014, during the process of clearing title, evidence of altering administrative record surface alleging Affiant is a White Supremacist leader and is selling property to fund White Supremacist group. Allegations prove false because

Affiant is of Latino descent and title clears April 3rd, 2014. Five weeks later Swift form Systems, Inc., withdraws allegedly due to delays, and

The week of August 10th, 2014 with the intent to list the property to pay debts caused by Mary Anne Melvin, Affiant calls Mr. R. Thomas owner/broker of Windemere Real Estate, in Whitefish, MT and affiant is told by Mr. Thomas that his firm does not engage in real estate scams and abruptly ends call, and

Mary Anne Melvin; Robert (Rob) Blair Young, his wife, Suzanne (Susanne) Young, William (Bill) Warren Melvin, his wife, Gail Jarvis Melvin and Floyd T. Huntington, in complicity with all the aforementioned individuals, Paladin International, LLC forfeits the property to Swift form Systems, Inc. to pay debts. It is all too obvious that Mary Anne Melvin's, under the protection of the U.S. is with the full intention was to gain the property and perpetuate the squatter status of her older brother Bill Melvin and Rob Blair, and

This is further evidenced by the following fact:

On August 28, 2014, Affiant is witness to the fact that Mary Anne Melvin under the protection of the U.S. re-routed official emails of the Government of The United States of America. The emails at generalpost.org are either missing or delayed. The email provider was called. Investigation reveals that emails are being re-routed to an un-intended recipient at tml@bresnan.net. The email belongs to Affiant's ex-wife Mary Anne Melvin, and

Additionally, there is evidence in the form of testimony and witnesses that Mary Anne Melvin made a deal with the IRS to bear false witness; spread lies and rumors to alter the administrative record and, establish a false profile of Affiant and all American Nationals of being "White Supremacists", and "Dangerous Domestic Terrorists", and
