

Affidavit

Comes now, Gregg Leo DeRusha, (hereinafter "Affiant") being competent to testify and being over the age of 21 years, after first being duly sworn according to law to tell the truth to the facts related herein states that Affiant has firsthand knowledge of the facts stated herein and believes these facts to be true to the best of Affiant's knowledge and belief, and


