
Comes now, Marshall Revellyn Rinkenberger, hereinafter Affiant, being competent to testify and being over the age of 21 years, after first being duly sworn according to law to tell the truth to the facts related herein states that Affiant has firsthand knowledge of the facts stated herein and believes these facts to be true to the best of Affiant's knowledge and belief.

On September 6, 2016, approximately 3:00 p.m., Deputy Sheriff David Laven, hereinafter Laven, drove onto Affiant's private field road past the No Trespassing sign one half mile to the woods. Laven got out of a Todd County police vehicle, approached Affiant's camper trailer and yelled is anyone here. Affiant went outside and Laven presented Affiant with three pages of paper. Affiant looked at the top paper and stated this is bullshit. Laven stated "I know and I am just the messenger". Affiant asked Laven for Laven's business card which Laven gave to Affiant. Laven walked back to the vehicle.

As Laven drove out, Affiant walked through the woods to see if there were any other squad cars ½ mile down the field road through the hayfield. Affiant saw Laven stop halfway down, get out and stand behind the vehicle. Laven looked back and to the left where Laven came from. Affiant could see that Laven was holding something up to Laven's eyes. Laven did not look toward the direction of where Affiant was in the woods. Laven got back into the vehicle, drove to the end of the field to County Road 66. Laven stopped by the No Trespassing sign, got out and went behind the vehicle, and looked again back toward the woods across the field. Laven was holding something up to his eyes again. Laven got back into the vehicle, turned right onto County Road 66 and drove away.

Affiant called the Chief Human Rights Defender, Joseph George, and reported the incident.
