Dear Sir,

The Human Rights Defenders International, the International Police for the Government of The United States of America has received the GLENN JOSEPH DERUSHA, PMA case back from the Department of State for the Government of The United States of America marked “unresolved”. This usually indicates a breakdown in Diplomatic attempts to resolve an International Incident.

It has been brought to my attention, Chief Joseph L. George III, concerning a one, Glenn Joseph DeRusha, a Human Rights Defender and a American National for The Government of The United States of America, in your custody, that on September 27 2016, a conversation took place between Marshall Rinkenberger, a Human Rights Defender and Matt Anderson, a Law Clerk for the Chief Judge; John Guthmann.

The Conversation entailed documents that were faxed to Matt Anderson. Defender Marshall Rinkenberger called to confirm if documents were received. The response from Matt Anderson was "Yes, we do not recognize these documents and are you a member of the bar? Second, it was reported that Matt Anderson also asked if one of our defenders was practicing law without a license.



I found that very disturbing nonetheless. Before this case is delivered to the Human Rights Tribunal and deposited into the nearest federal district court for dismissal under Title 28, Rule 17B, in harmony with Title 20, section 1 and 2 of the Universal Declaration of Human Rights. The Clerk for the General Post Master Council was wondering if Matt Anderson speaks on behalf of all of the private companies doing business as government within Ramsey County.

This question is asked because the state of Minnesota does have a reciprocal agreement with the Government of The United States of America concerning jurisdiction; see exhibits A, B, C.

This Government was under the impression that there was peace and mutual respect by and between the two entities. It does not want to move forward if in fact that the contempt shown towards the rule of law by Matt Anderson was a true reflection of Ramsey County as a whole or isolated too one in contempt.

If there is no response within 48 hours, this Government will assume that Matt Anderson's contempt for human rights is a reflection of Ramsey County as a whole and all of its companies that do business as government within it and will proceed with charging the Ramsey County entity number with Human Rights violations rather than individuals. Please keep in mind that the only point of jurisdiction this Government has over Ramsey County is the fact that Ramsey County is violating Human Rights against one of its persons. Without that connection, the Government of The United States of America is without any jurisdiction over Ramsey County.
