INTERNATIONAL PUBLIC NOTICE OF A CORRECTION OF AN INTERNATIONAL RECORD

Date: Friday, the 224th day in the year of Yahweh, 6018 (October 28, 2016).

The Human Rights Tribunal International is hereby convened under Article 8 of the Universal Declaration of Human Rights to correct the record for the following entities:

- 1: GLENN JOSEPH DERUSHA, PMA
- 2: MARSHALL REVELLYN RINKENBERGER, PMA

It was reported to the Human Rights Tribunal by a witness that foreign administrators were tampering with the established international record of two trustees serving the aforementioned entities.

The administrative record is extremely important due to the fact that the trustees voluntarily requested of the Government of The United States of America to establish an administrative record for the individuals in accordance to their religious, human and political rights.

The reason for the foreign company to alter any administrative record is not justified and does call into question the following human rights violations:

- 1: Fraud upon the independence of the judiciary.
- 2: Identity theft which results in human trafficking.
- 3: Violating the sanctity of the person, and
- 4: The Fraternal Order of Police does not have jurisdiction and the authority to impair the obligation of a contract nor does the American Association of Motor Vehicle Administrators.

He is sent by God for that very purpose. ⁵ Obey the laws, then, for two reasons: first, to keep from being punished, and second, just because you know you should.
