## GREAT WRIT

11-03-2016

## PETITION

By the authority of the office of the Governor for the Government of The United States of America, I, John Harold Fulks hereby issues this petition for Habeas Corpus in the form of the GREAT WRIT to secure the return of a person, GLENN JOSEPH DERUSHA, PMA from within the United States Government within one of its states, State of Minnesota case# 62-CR-16-178410212016 to 62-CR-16-178410212016-15 et al, that includes the District of Columbia.

## CLAIM

I, John Harold Fulks, by the power vested in me by the office of the Governor for the Government of The United States of America hereby claims the person styled: GLENN JOSEPH DERUSHA, PMA and its trustee on the following grounds thereby establishing a



challenge against the United States Government that it does not have the legal grounds to detain the aforementioned person:

**THE FOLLOWING GROUNDS ESTABLISH THE REASONS WHY THE UNITED STATES GOVERNMENT OPERATING UNDER THE DEFINITION OF A STATE THAT INCLUDES THE DISTRICT OF COLUMBIA IS NOTWITH STANDING TO DETAIN ONE OF THE PERSONS OF THE Government of The United States of America:**

1: President Barack Hussein Obama is strictly forbidden from arbitrarily arresting, detaining and exiling anyone from the States of the Union that are foreign to the United States under the rule of private international law. REF: Article 9 of the Universal Declaration of Human Rights.

2: President Barack Hussein Obama is strictly forbidden from denying anyone from claiming a Nationality or changing a Nationality. REF: Article 15 of the Universal Declaration of Human Rights.

3: President Barack Hussein Obama, even if a person was found within the United States that included the District of Columbia, and that person was doing business as a private membership association, does not have the authority to withhold any Rule of a court that would establish the record as having no jurisdiction over said person doing business as a private membership association within the United States.

4: President Barack Hussein Obama, "In EX parte Milligan (1866), Justice Davis delivered the opinion of the Court saying, "When it is impossible to administer criminal justice according to law, then, on the theatre of active military operations, where war really prevails, there is a necessity to furnish a substitute for the civil authority, thus overthrown, to preserve the safety of the army and society; and as no power is left but the military, it is allowed to govern by martial rule until the laws can have their free course. As necessity creates the rule, so it limits its duration; for, if this government is continued after the courts are reinstated, it is a gross usurpation of power. Martial rule can never exist where the courts are open, and in the proper and unobstructed exercise of their jurisdiction. It is also confined to the locality of actual war." Therefore, there are no current martial laws in the United States that would deprive any person of the right of a Great Writ to be issued on his or her behalf which has been incorporated into international human rights law.

5: The Government of The United States of America is not an enemy of the United States Government head quartered on Manhattan Island at the following address: 225 Liberty Street, New York, NY 10286, United States, nor is the Government of The United States of America an enemy of the Organization of American States head quartered at: 17<sup>th</sup> Street and Constitution Ave., N.W. Washington, D.C., 20006-4499, United States of America. In fact, when GLENN JOSEPH DERUSHA approached the Government of The United States of America (Government) through a resident declaration, the Government went to work to resolve





any outstanding issues, legal battles, or other problems on behalf of GLENN JOSEPH DERUSHA doing business as GLENN JOSEPH DERUSHA, PMA at: The United States of America, Global Postal Code: NAC: 76HFC QFV4G.

6: Federal Bureau of Investigations officer Agent Mark Kempe incited a foreclosure battle out of proportion as stated by Agent Mark Kempe by classifying GLENN JOSEPH DERUSHA as a domestic terrorist without any due process.

7: GLENN JOSEPH DERUSHA, PMA is not with the ability to sue or be sued within the United States in accordance with the policies of GLENN JOSEPH DERUSHA, PMA. Further, GLENN JOSEPH DERUSHA, PMA is recognized by association and precedence as a non-citizen, non-resident alien to the United States of America. GLENN JOSEPH DERUSHA, PMA has been found innocent of any crime by the Human Rights Tribunal International based on the investigation done by the Private Attorney General's Across America association entered into evidence at the Human Rights Tribunal International Public Record. The Government of The United States of America does possess the bailment rights of the person in this particular matter.

8: Currently, the trustee for GLENN JOSEPH DERUSHA, PMA, a Hebrew, is being tortured with cold temperatures and lack of adequate food intake for 44 days at present, in an attempt to coerce the trustee to accept arbitrary exile perpetrated by Ramsey County court and private detention center officers in Ramsey County, State of Minnesota under the Commander in Chiefs flag displayed in the Ramsey County Court room. The trustee for GLENN JOSEPH DERUSHA, PMA is not a member of any militia within the United States of America under the command of the Commander in Chief of the United States, Barack Hussein Obama.

9: Book III, chapter II, Law of Nations page 478 and 479: As the right of levying soldiers belongs solely to the nation or the sovereign (§7), no person must attempt to enlist soldiers in a foreign country, without the permission of the sovereign; and even with that permission, none but volunteers are to be enlisted: for the service of their country is out of the question here; and no sovereign has a right to give or sell his subjects to another. The man who undertakes to enlist soldiers in a foreign country without the sovereign's permission,—and, in general, whoever entices away the subjects of another state,—violates one of the most sacred rights of the prince and the nation. This crime is distinguished by the name of kidnapping or man-stealing, and is punished with the utmost severity in every well-regulated state.



## DEMAND

It is hereby demanded by the Government of The United States of America that international protocols are followed under a Great Writ and executed under customary international law and further that all foreign instruments are CANCELLED against GLENN JOSEPH DERUSHA doing business as GLENN JOSEPH DERUSHA, PMA, and the trustee is returned to the Government of The United States of America to stop the torture of the body and conscience of the trustee under a foreign military Commander in Chief of the United States, Barack Hussein Obama.
