Several officers were dispatched to the 17th District Court to respond to a disturbance in the courtroom. I went, along with Officers Strong, Butler and Bommarito, and Sgt. Turner. Over the duration of the incident several additional officers were present.

Some events occurred outside of my presence. Before my arrival, David Eugene Schied and Brent Justin Mohlman appeared in court to contest civil infraction citations, including a citation for an un-permitted privacy fence.

Schied refused to verbally identify himself in the courtroom. He was arrested for contempt of court on the order of Judge Khalil, and was walked to the police station jail by Officer Strong.

Mohlman addressed the court after Schied and did identify himself. He made some statements contesting the judge's authority and stated that his self-identification was made under duress.

Several other people became involved as associates of Mohlman and Schied. Some verbally identified themselves in the courtroom as Michael Liss (identified later as Michael James Liss), David "Molner" (possibly misheard "Mohlman"), and Ron Keller. David and Ron were not properly identified, as they were only required to verbally state their names. Liss was identified from a parked vehicle registration on later investigation.

After Schied's arrest a white male in his 40's arrived (heavy build, 5'09", balding with short gray hair). He verbally identified himself as a "people's attorney general", and he appeared to provide advice and support to the associates of Mohlman and Schied.

This man spoke to Court Officer Fischer in my presence. I heard him try to convince Officer Fischer that because Officer Fischer took an oath to uphold the Constitution, it was Officer Fischer's duty to arrest Judge Khalil when she returned to the courtroom from her chambers. He reasoned that Judge Khalil had exceeded her Constitutional authority, and was subject to arrest on that basis.

This man left the court after being in the courtroom for an hour or so. He was not seen associated with a vehicle.

Mohlman and his associates eventually left the court in their various vehicles.

Patricia Kraus appeared at the court and police station hours after the incident inquiring into Schied's arrest status.

Michael Rozewicz was not identified as being present. He is listed on a parked vehicle's registration :
Liss was seen driving the vehicle alone.

Marek Janek was not identified as being present. I
r. A white male and white female approximately in their 50's to 60's were with Schied and Mohlman in court, and were seen leaving in that vehicle.

The listed vehicles were parked in the court parking lot and on the street nearby, and were identified as associated with one or more of the involved people.

I was shown a letter that had been sent to the court by Brent Mohlman. In that letter, Mohlman stated (among other things) that any government official that enters without a warrant onto his property at (the location of the privacy fence in question) will be considered an intruder, and that necessary force may be used.

I was also shown a paper citation with writing on the reverse that Mohlman apparently wrote. It is a quotation from the Bible referring to the law of the lord, and the ungodly not standing in judgment.

While no threats were made or implied by the subjects involved in this event, their behavior was unusual, disturbing and disruptive to court business. This report is for information.
