

SUMMARY

On August 1, 2013 Three women and a mother were arrested and charged with 'custodial interference' for rescuing her 6yr. old from CPS, what is now known as the Department of Child Safety, who along with his older brothers were being physically abused, sexually molested, and even raped in foster 'care' and group homes in Phoenix, Tucson, and Peoria!

Two of the women agreed to plea bargain. DCS gave the mother a false promise that if she took a plea bargain DCS would return her sons. Instead DCS, along with the 'criminal' judicial system in Pima County terminated her parental rights and shipped the boys to Arkansas.

THE LION'S DEN

One of the women, Crystal Nuttle has stood her ground and refused to be coerced to take a plea. Crystal's court appointed attorney, Janet Altschuler, Tucson sold her out - did not form a defense for her and the day of the trial, Dec. 20, 2016 Altschuler lied to the court, claimed she spoke to Crystal and that "her client will not be requesting that the case be continued at this time." Presiding over this court hearing sat Judge Carmine Cornelio, who was unfit to sit on the bench, let alone be allowed to wear the distinguished robe of justice. One could conclude that he forced to retire at the end of 2016. Cornelio was sanctioned by the Commission on Judicial Conduct for several complaints between 2007 and 2013. Complaint numbers CJC-07-057, JC-13-0001, Commission No. 12-177. A news article found @ http://tucson.com/.../article_f0048f67-5b99-57e7-b40a-a9ecea0... reported "The Arizona Commission on Judicial Performance Review issued a 27-4 vote in June holding that Cornelio "does not meet" state judicial standards, meaning he should not be retained by voters in November, one of the strongest non-retention recommendations the commission has made over the last decade."

Pima County District Attorney Barbara Lawall, and her Deputy, Dawn Aspacher did everything they could do to protect the real criminals in this case – DCS who covered up the physical abuse, sexual molestation and rape of these boys entrusted to their care. April 13, 2015, they filed a 'Motion In Limine' to suppress evidence of the abuse these boys were suffering while in CPS' custody, and they wanted to make sure that there was no mention of the 6,000 cases of abuse reports which were not investigated. Because exculpatory evidence was withheld and suppressed from the jury we have heard that the jury found Ms. Nuttle guilty of assisting in the rescue of this child.

DCS' 2,392 pg. case file with regards to these boys is compiled with several case notes and police reports, which reveal repeatedly the mother and the boys, themselves reported physical abuse, sexual molestation and rape not only to DCS staff, but to the following Police Departments in Phoenix, Peoria, Sierra Vista, and Tucson. Two narratives from the police indicate two males were arrested for the crime of sexual assault – one arrested May 28, 2013 and the second arrested June 20, 2013.

Directly from this case file is the names of addresses of the foster/group homes where these boys endured these heinous acts of abuse not only covered up by DCS workers and police departments, but by judges, specifically Judge Carmine Cornelio, prosecutor, Pima County DA Barbara Lawall but court appointed attorneys, such as Janet Altschuler.

These are the group homes/foster placements where these boys suffered these heinous acts, who are still on the payroll of DCS and who Governor Ducey refers to the “unsung heroes” in his State to State Address on Jan. 9, 2017;
