YOU ARE HEREBY OFFICIALLY NOTIFIED THAT A WRITTEN STATEMENT HAS BEEN FILED WITH THIS DIVISION BY THE ARRESTING OFFICER CERTIFYING THAT ON DEC 29, 1994 THE OFFICER HAD REASONABLE GROUNDS TO BELIEVE THAT YOU WERE DRIVING A MOTOR VEHICLE IN THIS STATE WHILE UNDER THE INFLUENCE OF ALCOHOL.

THEREFORE, IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 17C, ARTICLE 5A, SECTION 1(C) OF THE CODE OF WEST VIRGINIA, YOUR PRIVILEGE TO OPERATE A MOTOR VEHICLE IN THIS STATE IS REVOKED.

YOUR LICENSE TO OPERATE A MOTOR VEHICLE IN WEST VIRGINIA CANNOT BE REINSTATED AFTER EITHER PERIOD UNTIL YOU HAVE SUCCESSFULLY COMPLETED THE SAFETY AND TREATMENT PROGRAM.

YOUR PRIOR BUI-RELATED SUSPENSION AND REVOCATION DATES INCLUDE: NONE

UPON YOUR WRITTEN REQUEST, THE COMMISSIONER OF MOTOR VEHICLES WILL ALLOW YOU AN OPPORTUNITY TO AN ADMINISTRATIVE HEARING. SUCH WRITTEN REQUEST MUST BE FILED NITH THE COMMISSIONER IN PERSON OR BY REGISTERED OR CERTIFIED MAIL, RETURK RECEIPT REQUESTED, WITHIN TEN (10) DAYS AFTER RECEIPT OF THIS ORDER. IF THIS IS DONE, THE ORDER WILL BE STAYED UNTIL THE END OF ANY HEARING WHICH RESULTS AGAINST YOU. THIS HEARING WILL BE HELD IN THE COUNTY WHERE THE ARREST WAS MADE UNLESS, BY AGREEMENT BETWEEN YOU AND THE COMMISSIONER, IT IS HELD IN ANOTHER

AFTER THE REVOCATION PERIOD, YOU WILL BE REQUIRED TO SUBMIT A \$15.00 REINSTATEMENT FEE. THE DIVISION REQUIRES THESE FEES TO BE PAID BY MONEY ORDER, CASHIER CHECKS, OR CERTIFIED CHECKS.

THIS NOTICE DOES NOT AFFECT ANY OTHER SUSPENSIONS OR REVOCATIONS CURRENTLY IN EFFECT OR THAT WILL TAKE EFFECT IN THE FUTURE. DRIVING WHILE YOUR LICENSE IS REVOKED IS PUNISHABLE BY COMPULSORY JAIL SENTENCE. IF YOU ARE CONVICTED OF DRIVING WHILE REVOKED, THE MY CODE MANDATES THAT YOUR REVOCATION PERIOD WILL BE EXTENDED BY ONE YEAR.
