

Affidavit of Richard Langley concerning the events of December 13, 2017 at 2521 Carthage Ave.

This affiant, Rick Langley, who resides at 2521 Carthage Ave, Pueblo Colorado does hereby state the following facts to the best of my knowledge; On the evening of December 13, 2017, my friend and neighbor, Michael Marshall brought pizza to my home and this affiant and Mr. Marshall enjoyed dinner and several hours of conversation together in my home. At approximately 9:30pm, Mr. Marshall left my home and was walking to his home, which is two houses down on the same side of the street, when this affiant almost immediately heard my tenant Marta Valdez, who lives in the basement of my home, yelling. When I stepped outside to investigate, this affiant witnessed Ms. Valdez yelling threats and pointing a rifle at Mr. Marshall, who was in the street and nearly to his home. Ms. Valdez was standing just outside my fence in the front yard.


Mr. Marshall returned to this affiant's home within a couple of minutes, although he never came onto my property or entered my yard. Mr. Marshall yelled at this affiant from the street, asking me if I was ok, to which I replied that I was fine. Mr. Marshall then told this affiant to call the police. During this time, Ms. Valdez, who was now back in this affiant's yard and near the entrance to the lower portion of my house that she rents, was still yelling threats and pointing the rifle at Mr. Marshall. Although Mr. Marshall was now carrying an ax, he NEVER at any time used it in ANY type of threatening or intimidating manner, toward anyone including Ms. Valdez, or made any threats to Ms. Valdez.

After seeing that this affiant was not in any danger from Ms. Valdez, Mr. Marshall returned the ax that he was carrying for his own protection to his home, then returned to this affiant's home where together we called 911 to report the actions of Ms. Valdez.

Let it be known that Ms. Valdez has threatened to kill this affiant, Mr. Marshall as well as my mechanic, on numerous occasions, or to have her son kill us although this was the first time that she brandished a weapon in a threatening manner.

Mr. Marshall has been a good neighbor and did not in my presence, that night nor at any other time that this affiant has witnessed, whether on my property or anywhere else, harm, injure or threaten another man or woman in any manner.

I swear that this affidavit is true and correct to the best of my knowledge.
