INTERNATIONAL PUBLIC NOTICE

Notice of Fault and Opportunity to Cure

July 20, 2018

On June 28, 2018, Shannon Lynn Reckner, the trustee for the SHANNON LYNN RECKNER, PMA (hereinafter "trustee") sent out an Affidavit of Termination of Power of Attorney and Withdraw/Cancel Signature for Good Cause to your organization as the material Fact of fiduciary trust fraud was brought to the knowledge of the trustee which has been perpetrated by your private foreign corporation(s).

Also note that there is no statute of limitations which applies to fiduciary trust fraud. It vitiates every authority, contract, and claim based upon it. As the initial cause of action was tainted by fraud and deceit and defective in all these respects, no subsequent action or claim of indebtedness could ever be justified.

As such operation of alleged law is unconscionable, and even under the foreign United States code, Title Sec 18 U.S.C. 1025, whoever, upon any waters or vessels within the special maritime and territorial jurisdiction of the United States, by any fraud, or false pretense, obtains from any person anything of value, or procures the execution and delivery of any instrument of writing or conveyance of real or personal property, or the signature of any person as maker, endorser, or guarantor, to or upon any bond, bill, receipt, promissory note, draft, or check, or any other evidence of indebtedness or fraudulently sells, barter, or disposes of any bond, bill, receipt, promissory note, draft, or check or any other evidence of indebtedness for value, knowing the same to be worthless or knowing the signature of the maker, endorser or guarantor thereof to have been obtained by any false pretenses, shall be fined or imprisoned not more than five years, or both.

As of this date, a verified rebuttal, answer or response has not been received by the Notary nor the trustee regarding the Affidavit of Termination of Power of Attorney and Withdraw/Cancel Signature for Good Cause thereby deeming the default provisions to be true and correct.

According to the trustee's rights pursuant to the Bilateral Social Compact Agreement by and between the people of The United States of America, and the Full Faith and Credit Doctrine, the trustee hereby accordingly, expressly and lawfully DEMAND a response from your department within ten (10) business days of your receipt of this Notice which 1) certifies, that the "name", which is written in ALL CAPITAL letters, or any derivative thereof, be removed and **immediately expunged** from any of your foreign private corporate files/records or case numbers and certify that such documents have been expunged from your files/records and the manner in which said expungement was accomplished; 2) explains why the live employees of this department have acted in bad faith, inasmuch as they failed to provide Full Disclosure with their involvement in such an artifice and scheme (according to the meaning of the original U.S. Constitution, Article 3, Section 3).

If the trustee or Notary presenter does not receive a verified response from your department by this reasonable deadline that is certified to be true, correct and complete, within the time specified; then **by your silence, you admit that you are a knowing party to this artifice or scheme to deprive the trustee of the intangible right of honest services** [cf. 18 USC Sec. 1346] thereby subjecting you to suit in an international Human Rights Tribunal, and further, War Crimes Tribunal court system without the United States. Additionally, by your silence, you are deemed to be in full agreement with the material Facts stated herein. Beyond that reasonable deadline, your silence will activate estoppel, and will also constitute a Fraud. The trustee is greatly anticipating your **full professional cooperation** in this Matter.
