INTERNATIONAL PUBLIC NOTICE

DECLARATION OF TRESPASS AND STOLEN PROPERTY

COMES NOW, Shannon Lynn Reckner, trustee for the SHANNON LYNN RECKNER, PMA (hereinafter “claimant”) whom is within the age of majority, competent to state the facts, hereby witnessed and publishing the following declaration to find and return the biological infant/child of the claimant whom is private posterity of the family, and claimant further states:

Kellan Andrej Leonard, born January 9, 2012 at Falmouth Hospital in the Town of Falmouth in the State of Massachusetts-Bay at 1:03 p.m. UTC-5 and is claimant’s biological infant/child. Claimant’s infant/child was abducted in the geographical area of the Town of Valdosta in the state of Georgia on March 2, 2015 at approximately 11:30 a.m. UTC-5 and has been missing ever since, and

It is believed claimant’s biological infant/child, Kellan Andrej Leonard has been seen in the geographical area of the Town of Falmouth and in the Town of Mashpee in the State of Massachusetts-Bay. The fingerprints, blood and RNA/DNA belonging to Kellan Andrej Leonard are lawfully held as private property within the SHANNON LYNN RECKNER, PMA and claimed under “first in time first in right” rule and,

as the biological mother of Kellan Andrej Leonard, claimant has an obligation to keep claimant’s infant/child safe, secure, happy and healthy and has tangible rights and intangible rights of consortium with the infant/child. As trustee over the SHANNON LYNN RECKNER, PMA claimant has an obligation to protect the interests and private property of the trust and those rights are recognized according to the Law of Nations and enforceable under customary international law, and

Any person having first-hand knowledge as to the whereabouts of Kellan Andrej Leonard, please respond immediately to the trustee for the safe return of the infant/child, and any person that has first-hand knowledge that does not come forward to respond to this declaration is hereby a willing party and/or accomplice to the theft and trespass of the Affiant’s personal property, and



will be subjected to the Human Rights Tribunal International, and War Crimes Tribunal court systems for human trafficking and other human rights violations and war crimes, and

This Public Notice of Declaration of Trespass and Stolen Property is hereby published in an international publication of record on the 18th day of July, 2018 and claimant further sayeth naught.
