COMES NOW, trustee for DONALD KANOELANI SOUZA, PMA (hereinafter “ affiant”), having reached the age of majority, competent to state the following facts herein, the beneficiaries having already been named and the affiant hereby publishes the following against the respondent(s):

JD Peacock II, (hereinafter; “respondent”)

The affiant hereby states that the respondent of the “IN THE CIRCUIT COURT OF FLORIDA’S FIRST JUDICIAL CIRCUIT IN AND FOR OKALOOSA COUNTY (SIC)” has been filing false reports within the subject matter of child abandonment against the affiant for over 17 years, and

The affiant hereby states that the respondent has been compliant with the legislative history of the statute starting with P.L. 81-734, within the legislative intent of the legislation requiring state welfare agencies to notify appropriate law enforcement officials upon providing AFDC to a child who was abandoned or deserted by a parent, and

The affiant hereby states that the respondent has been using the term “delinquent” to describe the following intent: “the legislation required state welfare agencies to notify appropriate law enforcement officials upon providing AFDC to a child who was “abandoned or deserted by a parent” thereby hiding the intent of the claim made by the respondent as actually accusing the affiant of abandonment or desertion of affiants child. Delinquent is not defined as abandonment or desertion of a child, and

The affiant hereby states that the affiant has never been openly accused of abandoning or deserting affiant’s child however, affiant has been routinely threatened with imprisonment over a 17 year period by the respondent wherein the respondent has been routinely threatening to file false police reports against the affiant throughout the aforesaid 17 years and did file a false police report on or before the 31<sup>st</sup> of July, 2020, and

The affiant hereby states that the America Bar Association is the main party responsible for the failure of self governance within its own program, and
