### **COMPILATION OF HUMAN RIGHTS VIOLATED**

**IT IS AGREED**, the **Human Rights Tribunal** concurs that the following articles of The Universal Declaration of Human Rights were in fact violated:

**Article 3: “Everyone has the right to life, liberty and security of person.”**

**Article 5: “No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.”**

### **INTERNATIONAL DAMAGE CLAIM AGAINST RESPONDENTS**

**The Human Rights Tribunal awards damages based on the following authority.**

**1: The Universal Declaration of Human Rights Declared Value in Continental Dollars!**

The Award is as follows:

1: Damages are hereby awarded to the Reinheimer family in the amount of One Million, Seventy One Thousand, Four Hundred Twenty Eight (+1,071,428.00) in Continental Dollars.

2: Punitive Damages: Whereas, upon each individual committing each violation individually and served in the presentment. The Punitive Damages awarded to the Reinheimer family are hereby assessed in the total amount of Eighteen Million, Two Hundred Fourteen Thousand, Two Hundred Eighty Eight (+18, 214,288.00) in Continental Dollars.

3: The Judgment Award has been assessed in Equity Jurisdiction and is subject to equity process fees.

4: The total amount at the exchange rate of one continental dollar to one U.S. Dollar is One Continental Dollar= One dollar and sixty three cents.
