Affiant never granted any obligations for respondent to claim a right to educate the affiant on religion and the affiant charges the respondent with forced association, and

The respondent has attained affiant’s intellectual property and has signed the affiant up for websites such as Plenty of Fish where affiant has received a verification code from Plenty of Fish with affiant’s number and name. Affiant has been signed up for car warranty’s and telemarketers, and

The respondent has went on Snapchat and placed the affiant's telephone number on Snapchat and has told people on Snapchat to shout out the number in order to have the affiant bombarded with calls from strangers, and

The respondent has been calling affiant's family members and have been sending pictures pictures of affiant's children to affiant's family members violating privacy rights of the family.

The affiant on affiant's facebook page would share a material item and the affiant mentioned that the item is cool and days later the item would show up at affiant's home without the affiant never ordering the product such as pillows and hoodies then the respondent has been scattering hearsay that the affiant owes the respondent money for the ordered item that the affiant has never requested from the respondent, and

The respondent started harassing the affiant's mother and sister, sending messages falsely claiming physical abuse to children and drug use and sale, and

The respondent upon naturalization within the States of the Union was kicked out of the American National Union of The United States of America for refusing to leave the affiant alone and til this day the respondent is still forcing the affiant into association and has been stalking and harassing the affiant, and
