## Motion



**COMES NOW**, in way of Representative Appointee for LESLEY JO GRANDE, PMA ( hereinafter “claimant” ) and authorized to investigate and bring findings to the Human Rights Tribunal International for human rights violations under the authorities of the Universal Declaration of Human Rights and the Law of Nations, the Representative Appointee Adam Samuel Ben-Canaan (hereinafter “co-trustee ) motions the court to hear cause and claim where relief can be granted and due process be upheld for all parties at all times, and

1. The claimant requests the following remedy as to the Human Rights Tribunal International to set fourth an injunction and permanent mandate for a restraining order for the claimant against the Respondent.
  - The mandate to instruct no communication either by physical or digital what so ever and permanently and to include no calling, texting, messaging in any form either by phone, computer, tablet, by any website or any way to communicate imaginable. Using a spoofing application is not acceptable.
  - No physical contact, do not go within 10 miles within claimant's place of settlement, home.
  - Never send any mail or send any gifts to the claimant.
  - No email contact
  - No third party contact and so fourth
2. The respondent with use of claimant's person without permission and consent of the claimant, the claimant requests the Human Rights Tribunal International to observe the claim and determination if a trespass of the aforementioned lien exists and adjudge accordingly upon conviction of the alleged charges and given all due process is upheld according to customary international law, and
