True Bill of Indictment



Claimant: Government of The United States of America v.

The Great Jury was accepted and acknowledged by the American National Union of The United States of America in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America.

The Great Jury for the American National Union of The United States of America hereby informs the Chief Notary of the Human Rights Tribunal International that the Great Jury convened to hear evidence presented by the claimant; and

It has been determined from the evidence presented that there is probable cause to charge listed respondents with the crimes of Rebellion or Insurrection, Seditious Conspiracy, Advocating Overthrow of Government, and Domestic Warfare against the American National Union of The United States of America and the Government of The United States of America for hijacking the aforementioned Union by removing all General Post Masters from the American National Union public communication platform with the crimes defined herein this publication [The following persons are under investigation for Rebellion or insurrection-Seditious conspiracy-Advocating overthrow of Government! – Continental Free Press](#); and

As evidenced below respondent, John Mark Adams expressed hostility toward General Post Masters and arbitrarily removed all General Post Masters from the American National Union public communications “Telegram” committee platform, depriving General Post Masters free speech, attacking family businesses, private member associations, etc., and stealing the American National Union from the people, in violation of the aforementioned respondent’s

oath of office, and further is a seditious act of rebellion or insurrection, after a notice of resignation was published in the American Herald from the office of Deputy Chairman for the Great Council of the American National Union of The United States of America, followed by a published notice declaring the American National Union of The United States of America was placed in trust. Therefore, respondent John Mark Adams violated Public Law(s) 101- 1, 101-7, 101-12, 101-17-2, and 101-23-4, and

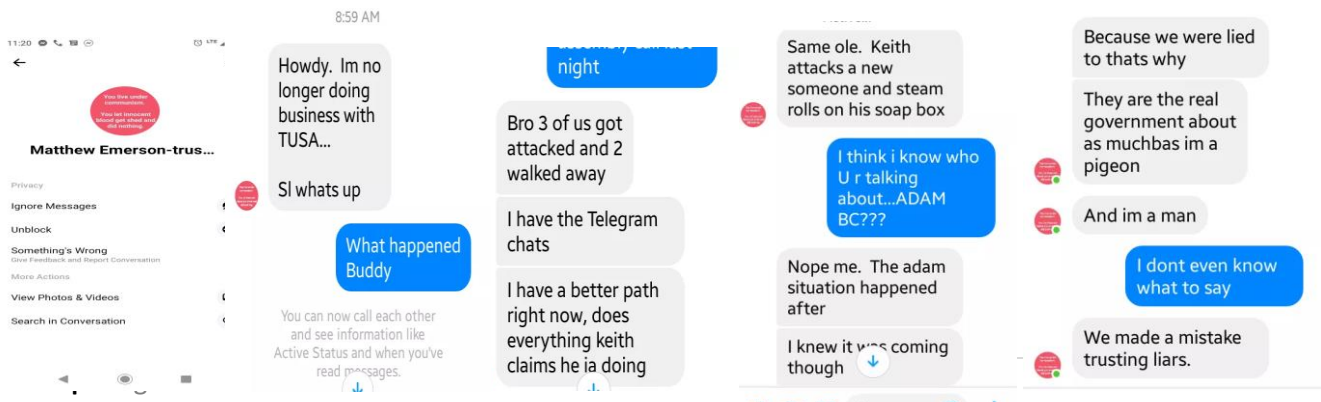

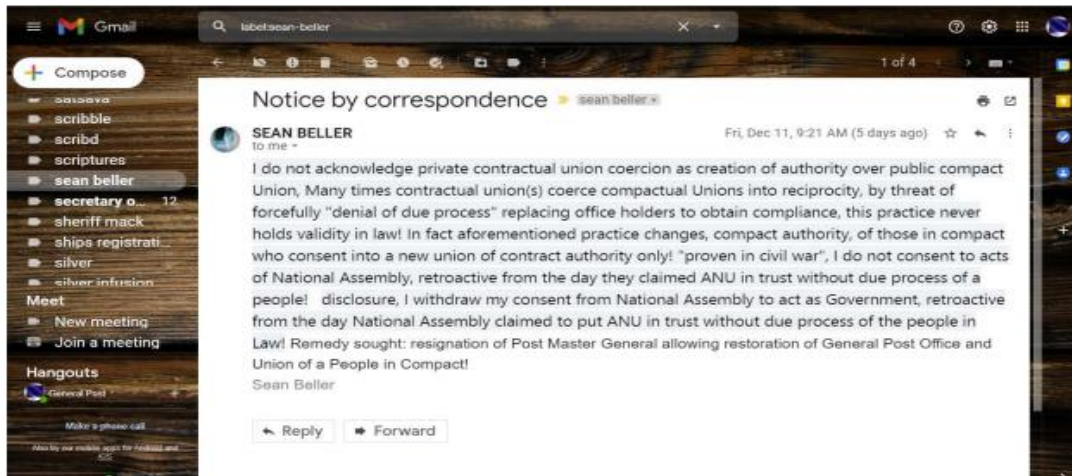
A conspiring rebuttal video, <https://vimeo.com/494850909>, was released on the 261st day in the year of Yahweh, 6022, translated December 5th, 2020, wherein respondents Adam Samuel Ben Canaan, John Mark Adams, Donald Kanoelani Souza, Michael Adam Fathauer, Justin James Yingling, and Jessene Roe Beecroft continued attacks on the integrity of the office of Post Master General of the General Post Office of The United States of America, further validating the aforementioned violations, and

Further, the Great Jury hereby finds sufficient evidence to charge respondent Valerie Zicaro with the following violations including but not limited to violating the 7th Law of Noah with a falsification of the international public record against the Government of The United States of America, and

Further, respondent Valerie Zicaro is hereby charged with violating Public Law 101-12 wherein the respondent published an arbitrary claim of "lunacy" against a public office holder in violation of due process of law to attack the reputation of the aforesaid public office holder as evidence herein within this publication of record: [Public Notice for Valerie Zicaro and Jason Perez – American Herald](#) in an attempt to assassinate the international character of the Government of The United States of America with public comments by Jason Smith Perez aiding the arbitrary claim against the public office holder, also violating Public Law 101-12 wherein the respondents attempted to defame the reputation of all claims made in the name of the established international person within the Law of Nations known within the family of Nations as the Government of The United States of America, and



As evidenced above, there is sufficient reason to charge respondent Matthew Joseph Emerson with violating the 7th Law of Noah by bearing false witness against the Government of The United States of America, therefore violating his social compact agreement, and



As evidenced above, on the 268th day in the year of Yahweh, 6022, translated December 11th, 2020, an electronically mailed document from respondent Sean William Gary Beller, in his own capacity, disavowed the National assembly and sought remedy with the resignation of the Post Master General vacant any evidence for the respondents allegations, and is vacant any due process of law needed for such a remedy, therefore committing sedition with rebellion or insurrection, violating Public Law(s) 101-1, 101-6, 101-7, 101-8, 101-12, and 101-15, and

As stated in the Law of Nations; Book 1, Chapter 3 § 30, Of the support of the constitution and obedience to the laws; “ The constitution and laws of a state are the basis of the public tranquility, the firmest support if political authority, and a security for the liberty of the citizens. But this constitution is a vain phantom, and the best laws are useless, if they be not religiously observed: the nation ought then to watch very attentively, in order to render them equally respected by those who govern, and by the people destined to obey. To attack the constitution the state, and to violate its laws, is a capital crime against society; and if those guilty of it are invested with authority, they add to this crime a perfidious abuse of the power with which they are intrusted. The nation ought constantly to repress them with its utmost vigor and vigilance, as the importance of the case requires. It is very uncommon to see the laws and constitution of a state openly and boldly opposed: it is against silent and gradual attacks that a nation ought to be particularly on its guard. Sudden revolutions strike the imaginations of men: they are detailed in history; their secret springs are developed ”, and

The names of witnesses to be included for this True Bill of Indictment are: Keith Livingway, Brandon Alan Anderson, and Brandon Gibbs, and

We the Great Jury declare that in this Bill exists a special case whereby many or all of those serving as jurors could be considered an injured party yet, had to move forward with the evidence and a true bill in this case or those who had committed the offence would go untried.
