

AFFIDAVIT

Date- The 277th Day in the year of YHWH, Translated December 20th, 2020

Comes now Brandon Alan Anderson, Trustee (hereinafter "Affiant") being competent to testify and being over the age of twenty-one years, after first being duly sworn according to the law to tell the truth to the facts related herein states that Affiant has first- hand knowledge and belief that these facts are true to the best of Affiant's knowledge and belief, and;

1. The Affiant states that on the 159th Day in the year of YHWH 6022, translated- August 24th, 2020 while attending a National Assembly for the Government of The United States of America Affiant heard that Adam Ben-Canaan (hereinafter "Respondent (A)") was teaching classes. Affiant saw an Ad on Facebook for said classes. Affiant contacted Respondent (A) on Facebook messenger and stated that Affiant saw an Ad on Facebook and believed this would-be good information to have. Respondent (A) stated that classes would cost 45 USD. Respondent (A) informed Affiant that the classes would consist of Chain of Title, Court Structure, and an Affidavit class. Affiant agreed that this was a fair price and was informed by Respondent (A) that the classes would be held on the 162nd Day in the year of YHWH 6022, translated- August 27th 2020.
2. Affiant states that payment was sent on the 161st Day in the Year of YHWH 6022, translated August 26th, 2020 in the amount of 45 USD through Paypal to Respondent (A) for Affiant to take the classes. The receipt shows the name of a Lesley Grande.
3. Affiant states that on the night of 162nd Day in the year of YHWH, translated- August 27th 2020, Affiant met Respondent (A) on a Zoom call, to start the classes. Affiant listened to Respondent (A) and took handwritten notes, the titles of the classes taken are labeled Chain of Title, Court Structure, and Affidavit. A second student appeared at the begging of the Affidavit class. Classes have been listed in order.
 - a. Affiant states that the Chain of Title class notes consist of the chain of title regarding The United States of America and how chain of title was claimed.
 - b. Affiant states that the Court Structure class notes consist of the structure of court, and how to work within the courts under different statuses
 - c. Affiant states that the Affidavit class consisted of going over Respondent (A)'s affidavit created on July 17, 2017.

4. Affiant states that close to the 176th Day in the year of YHWH, translated- September 10th, 2020 while attending reign of the heavens Temple, Keith Livingway (hereinafter "Witness (1)") stated that the classes Respondent (A) was teaching may not be adequate. Affiant admitted to Witness (1) that Affiant had taken Respondent (A)'s classes and Affiant had handwritten notes on the subjects taken. Witness (1) asked Affiant if he could read the notes taken. Affiant responded by reading the notes in Temple. Witness (1) stated that the Chain of Title course should be dealing with a different subject entirely, and that Affiant could have received the same information for free, from the T-ROH show.
5. Affiant states that on the 258th Day in the year of YHWH, translated- December 1st, 2020, while on the ANU Telegram group, Respondent (A) stated that anyone who stands up for Witness (1) is part of a dictatorship or something similar to and should just not respond. Respondent (A) stated that what had happened to him was unfair and had a large group of people backing Respondent (A). Affiant responded that for Respondent (A) to imply that someone standing up for the truth is than accused of being part of a dictatorship is a disgusting accusation. Affiant then provided what the classes consisted of on the ANU Telegram group, and that Affiant was neither Judge nor Jury to decide if what had happened to Respondent (A) was appropriate. Witness (1) stated that what Respondent (A) was doing was inappropriate. Affiant responded that Affiant regretted taking the classes, that after Affiant went back and watched more of the T-ROH show Affiant concluded the same information that was given in the Chain of Title class. Respondent (A) accused Affiant of being a "Kiss ass" and that Respondent (A) also regretted that Affiant took his classes. Affiant replied that he kisses no one's ass. Witness (1) stated that Witness (1) knows that Affiant is not a kiss ass, and that this is just Respondent (A)'s way of trying to silence people. Affiant states that conversation pursued between Respondent (A) and Witness (1) wherein Respondent (A) was attacking Witness (1) through a form of Gaslighting. Affiant stopped responding on the ANU telegram group at this time.
6. Affiant is making a transition in life. Walking the Narrow way consists of brutal honesty and when a question arises, if Affiant does not speak, it is just as bad as lying.
7. Affiant states that later that night on the 258th day in the year of YHWH, translated- December 1st 2020 he went back on the ANU Telegram group. Tom Goudy (hereinafter "Witness (2)") was having a conversation. Affiant saw a Public Notice stating that the ANU was declared an Illegal Autonomous Zone. Affiant left the ANU Telegram group shortly after this before reading what Witness (2) was typing.


